## Gays Mills Apple Fest/Fall 2025

<u>Dates</u>: Friday, Saturday and Sunday, September 26, 27, and 28, 2025 9:00 AM To 5:00 PM (4 PM Closing on Sunday)

**Spaces:** All spaces are located at the Crawford County Fairgrounds at 17725 State Highway 131 in Gays Mills, Wisconsin. The Lions Club will make every effort to provide vendors the same spaces as they've used in previous years. Due to contractual obligations to the County Fair Board, we prefer that there be no early set-ups before Thursday. If **outdoor** vendors <u>absolutely</u> need to arrive on Wednesday because of travel distances and set-up workload, we will accommodate you. However, because of the extra cost of renting exhibit buildings for an additional day, <u>indoor</u> vendors may NOT set up until <u>Thursday</u>. Vendors may not set up without being checked in by a Lions member between approximately 8 am and 5 pm, but earlier on the day of the show. If you are a direct seller for a company that restricts the number of sellers that may appear at the same show, please indicate that on your registration form; we will accept the first seller for that company and do our best to identify and notify subsequent registration requests representing the same company – <u>however</u>, the Lions Club will **NOT** be responsible for consequences resulting from duplicate sellers from the same company participating in the Flea Market.

**Exhibition**: There are outdoor (20' by 60') and indoor (6' by 20') spaces. If you want more than one space, you should plan on setting up early to ensure you can occupy adjacent spaces.

<u>Registration</u>: The registration fee is \$110 per space covering all three days. Pre-registration is strongly encouraged, but not required. Fees are non-refundable. No commission is charged on your sales. Return your registration form – and tax form -- and check made payable to "Gays Mills Lions Club" to the address below. If you want confirmation of your registration, enclose a self-addressed stamped envelope, or call or e-mail to the contacts listed below.

<u>Additional Spaces at Apple Fest:</u> Call the Gays Mills Village Clerk at 608-735-4341 for vendor spaces on and near Main Street in the downtown area. The Lions Club also operates the Arts and Crafts Show at the Fairgrounds.
